I further agree to indemnify and hold White Oak Ranch, and/or its agents, employees, affiliates, successors and assigns, harmless from and against any and all claims, liabilities, loss, damage, demands, actions, causes of action, attorney's fees or expenses of any kind or character whatsoever, which may be made against them, or any of them, arising out of my entering upon White Oak Ranch's property for the purposes stated above.

THE MANAGEMENT AT WHITE OAK RANCH ARE NOT PRESENT FOR PURPOSES OF DETERMINING WHETHER YOUR RIDING ABILITY IS SUFFICIENT FOR YOUR HORSE; NOR ARE THEY ON THE PREMISES TO ENSURE THAT YOU EXERCISE THE PROPER STANDARD OF CARE AROUND ANIMALS.

I agree and understand that all riding engaged in at White Oak Ranch is solely at my own risk, and that White Oak Ranch is not liable for any injury which may occur to me on its premises, whether bodily injury or otherwise. I further agree to release White Oak Ranch, its agent's employees, volunteers and management for any and all liability for any injuries I may sustain while on the property, and agree to indemnify and hold White Oak Ranch harmless as to all claims, actions, damages, costs and expenses, including attorney's fees, arising there from.

The aforesaid release and limitation of liability extends to, without limitation, any obligations of the White Oak Ranch with respect to consequential damages and negligent behavior of any of its employees, management, or volunteers. This agreement shall not be extended, altered or varied except by written instrument signed by Ann or Ray Vincent.
